  - \*Ensure compliance to JFF's Code of Conduct Policy (MNG 653)
  - \*Have a program for the prevention of counterfeit parts.

\*Any JFF requested adjustments must be verified prior to production.

\*If the Vendor chooses to proceed with production prior to First Piece Approval, this is done at the Vendor's risk. JFF will not be liable for costs incurred in this circumstance.

\*JFF reserves the right of final approval of product, procedures, processes, and equipment.

AS PART OF THIS PURCHASE ORDER IT IS REQUIRED TO:

- 2. State that you are in compliance with the DFARS 252.225-7008, DFARS 252.225-7009, and DFARS 252.225-7010
- Alt. 1 regulation on the material certification.

This purchase order applies to our Term and Conditions of Purchases for Goods and Services Agreement, Revision date October 12, 2017.

JFF Supplier will comply with all applicable U.S. Government export control laws and regulations (ITAR, EAR).

Suppliers will communicate any issues pertaining to this purchase order by contacting the buyer.

No design or development authorized by external providers.

JFF will be permitted to verify and validate activities on external providers premise as state on purchase order.

JFF evaluates external providers for quality and delivery performance annually.

Suppliers shall have a program for the prevention of counterfeit parts.
